Payment Information

The client will pay the total fee for this service which is £_____ for _____ hours of entertainment. If the client requests additional hours, Ritzee Entertainment is able to provide them, the fee will be £42 per additional hour. This is at DJs own discretion.

The client agrees to pay a deposit on day of booking, in the amount of £_____. This deposit is non-refundable.

The client will pay the balance due on or before the date of the event.

If the client wishes to cancel the services, the client must give Ritzee Entertainment at least 14 days' notice. Any cancelations after that point will result in the full balance being due immediately.

Payments may be made via Cash, Check or Bank Transfer. Booking will not be confirmed until deposit is payed and cleared

If the client changes times, location or any important details to the event Ritzee Entertainment reserve the right to change the charge or cancel the services.

Performer expenses

The client will furnish the sole cost and expense of travel and equipment transportation for the performer and equipment for performance when travel time is over 25 minutes. Client will pay £0.45 per mile.

Cancellation

Ritzee Entertainment reserves the right to cancel this agreement without obligation upon written notice to the client. In the unlikely event the Performer cancels the performance under the terms of this section. The deposit will be returned to the client promptly.

Requirements

Ritzee Entertainment will require you to provide a list of earliest times to enter the venue on the day of event, and a list of what the venue provides (Built in sound system, Lighting systems, etc.)

The client will be responsible for providing suitable power and electricity for the set-up and performance. If outdoors Client must provide overhead waterproof and windproof cover in the DJ setup area.

The client will provide all Liability insurances needed for the event.

The client warrants and represents that they have obtained any and all permits, approvals and licenses and variances required for the performance

Force Majeure

Neither Ritzee Entertainment or the client will be held liable for any failure to perform its obligations under this agreement where such breach is due to any of the following: acts of regulations of public authorities, Labour difficulties or strike, epidemic, interruptions or delay of transportation services, acts of god, or any other legitimate

Music

If you require Clean/Radio edits for your event, please make this clear when booking your event or at the earliest convenience. Please return the music request list 14 days before your event.

Advertising

The client will be responsible for all promotion of the event. The client agrees to promote with appropriate measures to the best of their ability.

The performer agrees that the client may use the performers name, photographs, and other likeness to promote the performance. The client's right to use Ritzee Entertainment starts when this agreement is signed and ends at the completion of the performance.

Damages

It is hereby further agreed that the Client shall be held liable for any injury or damages to the DJ, Guests or property of the DJ or venue while at the Event if damage is caused by Location malfunction, Client, members of his organization, guests, employees, or any other party in attendance, whether invited or not. And will be liable to pay the total cost for replacement or repair. If the performance is outdoors, the DJ reserves the right, in good faith, to stop or cancel the DJ Service if the weather poses a potential danger to DJ or DJ's equipment. Every effort will be made to continue the DJ Service during inclement weather.

Payments

Deposits are due on day of booking to "lock-in" your date and booking. Deposits are non-refundable. The remaining balance is due on day of event, Ritzee Entertainment have the right to delay set-up until full payments are made. We understand sometimes hiring a DJ can be expensive in some cases we are able to offer payment instalments. We accept Checks, Bank Transfer, PayPal and Cash in hand a 10% late fee will be added to outstanding invoices
